PROPOSED ROUTE (S-N)

GENERAL CENTERLINE DESCRIPTION FOR THE PROPOSED ROUTE

FROM A POINT IN BEGINNING WITH COORDINATES OF APPROXIMATELY 38°45'20.22"NORTH LATITUDE AND 89°58'47.58"WEST LONGITUDE IN SECTION 34, TOWNSHIP 4 NORTH, RANGE 8 WEST IN MADISON COUNTY, ILLINOIS;

THENCE NORTHERLY APPROXIMATELY 340 FEET THROUGH THE NORTH HALF OF SECTION 34 IN SAID TOWNSHIP AND RANGE TO THE SOUTH RIGHT OF WAY LINE OF INTERSTATE 270;

THENCE EASTERLY ALONG THE SOUTH RIGHT OF WAY LINE OF INTERSTATE 270 APPROXIMATELY 1,392 FEET THROUGH THE NORTH HALF OF SECTION 34 OF SAID TOWNSHIP AND RANGE TO THE WEST RIGHT OF WAY LINE OF SOUTH MAIN STREET;

THENCE NORTHEASTERLY ALONG THE WEST RIGHT OF WAY LINE OF MAIN STREET AND GLEN CARBON ROAD APPROXIMATELY 1,160 FEET THROUGH THE NORTH HALF IN SECTION 34 IN SAID TOWNSHIP AND RANGE TO THE SOUTH RIGHT OF WAY LINE OF EAST INGLE DRIVE;

THENCE EASTERLY ALONG THE SOUTH RIGHT OF WAY LINE OF EAST INGLE DRIVE APPROXIMATELY 2,728 FEET THROUGH THE NORTH HALF OF SECTIONS 34 AND 35 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHWESTERLY A HEADING OF APPROXIMATELY 216 DEGREES A DISTANCE OF APPROXIMATELY 190 FEET THROUGH THE NORTH HALF OF SECTION 35 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 110 DEGREES A DISTANCE OF APPROXIMATELY 193 FEET THROUGH THE NORTH HALF OF SECTION 35 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE EASTERLY APPROXIMATELY 2,025 FEET THROUGH THE NORTH HALF OF SECTION 35 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHERLY APPROXIMATELY 160 FEET THROUGH THE NORTH HALF OF SECTION 35 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE EASTERLY APPROXIMATELY 207 FEET THROUGH THE NORTH HALF OF SECTION 35 OF SAID TOWNSHIP AND RANGE TO A POINT ON THE EAST RIGHT OF WAY LINE OF TROY ROAD;

THENCE NORTHERLY APPROXIMATELY 570.25 FEET THROUGH THE NORTH HALF OF SECTION 35 AND THE SOUTH HALF OF SECTION 26 OF SAID TOWNSHIP AND RANGE TO A POINT ON THE EAST RIGHT OF WAY LINE OF TROY ROAD;

THENCE EASTERLY APPROXIMATELY 1,245 FEET THROUGH THE SOUTH HALF OF SECTION 26 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 83 DEGREES A DISTANCE OF APPROXIMATELY 765 FEET THROUGH THE SOUTH HALF OF SECTION 26 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 75 DEGREES A DISTANCE OF APPROXIMATELY 545 FEET THROUGH THE SOUTH HALF OF SECTION 26 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 65 DEGREES A DISTANCE OF APPROXIMATELY 107 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 128 DEGREES A DISTANCE OF APPROXIMATELY 230 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 106 DEGREES A DISTANCE OF APPROXIMATELY 828 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 63 DEGREES A DISTANCE OF APPROXIMATELY 1,927 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 151 DEGREES A DISTANCE OF APPROXIMATELY 1,235 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 59 DEGREES A DISTANCE OF APPROXIMATELY 1,156 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHWESTERLY A HEADING OF APPROXIMATELY 327 DEGREES A DISTANCE OF APPROXIMATELY 1,600 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 69 DEGREES A DISTANCE OF APPROXIMATELY 1,170 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 160 DEGREES A DISTANCE OF APPROXIMATELY 61 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 71 DEGREES A DISTANCE OF APPROXIMATELY 133 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE TO A POINT;

THENCE EASTERLY A DISTANCE OF APPROXIMATELY 650 FEET THROUGH THE SOUTH HALF OF SECTION 25 OF SAID TOWNSHIP AND RANGE AND SECTION 30 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHERLY AND PARALLEL WITH THE WEST LINE OF RANGE 7 A DISTANCE APPROXIMATELY 410 FEET THROUGH THE NORTH HALF OF SECTION 30 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 70 DEGREES A DISTANCE OF APPROXIMATELY 2,042 FEET THROUGH THE NORTH HALF OF SECTION 30 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHERLY A DISTANCE OF APPROXIMATELY 6,812 FEET THROUGH THE WEST HALF OF SECTIONS 30 & 19 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHWESTERLY A HEADING OF APPROXIMATELY 332 DEGREES A DISTANCE OF APPROXIMATELY 304 FEET THROUGH THE WEST HALF OF SECTIONS 19 AND 18 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT ON THE NORTHWEST RIGHT OF WAY LINE OF GOVERNORS PARKWAY;

THENCE NORTHEASTERLY AND PARALLEL TO THE NORTHWEST RIGHT OF WAY LINE OF GOVERNORS PARKWAY A DISTANCE OF APPROXIMATELY 1,008 FEET THROUGH THE SOUTH HALF OF SECTION 18 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHERLY A DISTANCE OF APPROXIMATELY 1,836 FEET THROUGH THE EAST HALF OF SECTION 18 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE EASTERLY A DISTANCE OF APPROXIMATELY 1,962 FEET THROUGH THE SOUTH HALF OF SECTION 18 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT ON THE WEST RIGHT OF WAY LINE OF RIDGE VIEW ROAD;

THENCE EASTERLY AND APPROXIMATELY PARALLEL WITH THE NORTH RIGHT OF WAY LINE OF GOVERNORS PARKWAY A DISTANCE OF APPROXIMATELY 2,958 FEET THROUGH THE NORTH HALF OF SECTION 17 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHEASTERLY A HEADING OF APPROXIMATELY 1.3 DEGREES A DISTANCE OF APPROXIMATELY 6,694 FEET THROUGH THE EAST HALF OF SECTIONS 17 AND 8 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE EASTERLY A DISTANCE OF APPROXIMATELY 2,240 FEET THROUGH THE NORTH HALF OF SECTION 8 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE NORTHERLY AND PARALLEL WITH THE WEST RIGHT OF WAY LINE OF BLACKBURN ROAD A DISTANCE OF APPROXIMATELY 2,800 FEET THROUGH THE EAST HALF OF SECTIONS 8 AND 5 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT;

THENCE EASTERLY A DISTANCE OF APPROXIMATELY 61 FEET THROUGH THE SOUTH HALF OF SECTION 5 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT ON THE EAST RIGHT OF WAY LINE OF BLACKBURN ROAD;

THENCE NORTHERLY A DISTANCE OF APPROXIMATELY 3,555 FEET THROUGH THE WEST HALF OF SECTION 4 OF SAID TOWNSHIP AND RANGE 7 WEST TO A POINT ON THE NORTH RIGHT OF WAY LINE OF COUNTY ROAD 44;

THENCE NORTHWESTERLY AND PARALLEL WITH THE NORTH RIGHT OF WAY LINE OF COUNTY ROAD 44 WESTERLY A DISTANCE OF APPROXIMATELY 3,289 FEET THROUGH THE SOUTH HALF OF SECTION 32 OF TOWNSHIP 5 NORTH AND RANGE 7 WEST TO A POINT;

THENCE SOUTHEASTERLY A HEADING OF APPROXIMATELY 177 DEGREES A DISTANCE OF APPROXIMATELY 90 FEET THROUGH THE WEST HALF OF SECTION 32 OF TOWNSHIP 5 NORTH AND RANGE 7 WEST TO A POINT ON THE SOUTH RIGHT OF WAY LINE OF COUNTY ROAD 44;

THENCE NORTHWESTERLY AND PARALLEL TO THE SOUTH RIGHT OF WAY LINE OF COUNTY ROAD 44 A DISTANCE OF APPROXIMATELY 1,620 FEET THROUGH THE SOUTH HALF OF SECTION 32 OF TOWNSHIP 5 NORTH AND RANGE 7 WEST TO A POINT;

THENCE SOUTHWESTERLY AND PARALLEL TO THE SOUTH RIGHT OF WAY LINE OF COUNTY ROAD 44 A DISTANCE APPROXIMATELY 390 FEET THROUGH THE SOUTH HALF OF SECTION 31 OF TOWNSHIP 5 NORTH AND RANGE 7 WEST TO A POINT OF TERMINATION.
