Pure Power is offered in half-blocks of 500 kilowatt-hours (kWh), full-blocks of 1,000 kilowatt-hours (kWh) or matches 100% of your estimated electricity usage. Half-blocks (500 kWh) are for residential customers only. Full-blocks (1,000 kWh) are available for all customers. The percent of use product matches 100% of your estimated electricity usage and is available for residential and certain classes of commercial customers. This table provides the renewable resource mix in Pure Power in 2022, as well as the projected resource mix in 2023.

How will I be billed?	Participants who have voluntarily enrolled in the program will see a line item on their Ameren Missouri bill each month for Pure Power which will represent the additional charges over and above their regular utility bill.
How will my bill be calculated?	<p>Residential and Small Commercial Customers: Usage-Based Option: Ameren Missouri residential and small commercial customers participating in Pure Power will be charged an additional 1.0 cents per kilowatt-hour (kWh) for 100% of their energy usage. Example: energy usage is 1,017 kWh per month. Pure Power charges are 1.0 cents x 1,017 kWh = \$10.17 extra per month.</p> <p>Block Option for all customers including medium and large businesses: All Ameren Missouri customers are able to participate by purchasing 1,000 kWh "blocks" of Pure Power for \$10 per block. These customers can purchase as many blocks as they want. Example: A business elects to buy 10 blocks per month. Pure Power charges are 10 blocks x \$10 = \$100 premium per month.</p> <p>Residential customers have the option to participate by purchasing a 500 kWh "half-block" of Pure Power for \$5.00 per half-block.</p>
How much will my total electricity service cost, including utility charges?	<p>Residential and Small Commercial Customers: Usage-Based Option: Based on a monthly average usage of 1,017 kWh, the following provides an estimate for a 2023 electricity bill and highlights the Pure Power premium for supporting local renewable energy. Your actual bill will vary based on your use of electricity.*</p> <p>Average Monthly Electricity Cost (\$105.16) + Pure Power (\$10.17) = \$115.33 Total</p> <p>*does not include municipal taxes or fuel adjustment charges</p>
Will my rates change over time?	While the cost of regular electricity may vary over the years the premium for Pure Power will remain consistent.
What sources will be used in my certified product?	A minimum of 25% of the renewable generation facilities supported by Pure Power must be located in Missouri. Non-Missouri renewable generation will be sourced from Illinois, Iowa, Kansas, Arkansas, Kentucky, Nebraska, Oklahoma, and Tennessee. Please see the Product Content Label for additional details about the product mix.
If I want to terminate this agreement, what is the early termination fee?	There is no termination fee for residential or commercial customers.
What length of agreement/contract is required?	There is no minimum length of agreement for customers. Participants enroll once in Pure Power and remain enrolled unless they choose to cancel. All customers can cancel at any time without penalty.
What other fees might I be charged?	No other fees apply.
What happens if I move?	If you move within Ameren Missouri's service territory, your Pure Power enrollment will transfer to your new service address.
