Notes:

- (1) Prior to January 2, 2007, the Lighting Tariffs contained separate categories and charges for Street and Protective Lighting and separate charges between residential and non-residential. Effective January 2, 2007, prices are the same regardless of prior category. Starting in June 2017, LED Lighting will be installed on a replace-fail method.
- (2) Variable charges include Energy Charge, Distribution Delivery Charge, Energy Distribution Tax and Rider TS Charge.
- (3) Monthly kWh is based on an average yearly kWh. Actual kWh may vary monthly depending on the month.
- (4) Customers taking service under Mercury Vapor and certain Metal Halide lighting service prior to January 2, 2007, shall be allowed to continue operation until the fixtures require major maintenance. Mapping of the old fixture to the new fixture can be found in the Rate DS-5 - Lighting Service tariff.
